Terms and Conditions

1. Open-access Options. Subject to the terms outlined in the University of Wyoming (University) *Rocky Mountain Geology* (RMG) Open-access Publication Policy (available at <https://geobookstore.uwyo.edu/rmg/openaccess>), Author hereby chooses one of the following publication options (check or circle one):

- Option 1**, an access-controlled, 'traditional (green) model.'
- Option 2**, an author-subsidized, 'fully open-access (gold) model.'

2. General Terms and Conditions. Regardless of the option chosen, the following terms and conditions apply:

- A. Grant of Publishing Rights.** Author hereby grants to the University a non-exclusive, worldwide, royalty-free, perpetual, irrevocable, transferable, and sub-licensable license to publish, reproduce, and distribute all or any part of the Work in any and all forms of media, now or hereafter known, including in the above publication, and to authorize third parties to do the same. Author shall execute and deliver to the University any and all documents that the University reasonably deems necessary or appropriate to evidence or effectuate the rights granted herein.
- B. Permission.** Author warrants that he/she has the copyright or other intellectual property right or permission to grant these rights. In the event that any materials used in the Work contain the work of third-party individuals or organizations, Author will secure any necessary permissions and/or licenses to allow the University to publish, reproduce, and distribute all or any part of the Work.
- C. Warranty and Indemnification.** Author warrants and represents that he/she has the full right, power, and authority to enter into this Agreement and to grant the rights granted herein and that the University's inclusion and use of the Work will not violate any rights of any kind or nature whatsoever of any third party. Author shall indemnify and hold harmless the University, its successors, assigns, and licensees, and the respective officers, directors, agents, and employees, from and against any and all claims, damages, liabilities, costs, and expenses (including reasonable attorneys' fee), arising out of or in any way connected with any breach of any representation or warranty made by the Author herein.

D. Additional Requirements. Author acknowledges and agrees that the Work is also subject to the licensing terms and conditions of version 3 of Creative Commons (CC)-BY available at <http://creativecommons.org/licenses/by/3.0/us>, which is hereby incorporated herein.

E. Severability. Should any portion of this Agreement be judicially determined to be illegal or unenforceable, the remainder of the Agreement shall continue in full force and effect.

F. Governing Law. The construction, interpretation, and enforcement of this Agreement shall be governed by the laws of the State of Wyoming. The courts of the State of Wyoming shall have jurisdiction over any action arising out of this Agreement and over the parties, and the venue shall be the Second Judicial District, Albany County, Wyoming.

G. Legal Authority. Author warrants that it possesses the legal authority to enter into this Agreement and that he/she has taken all actions required by any applicable regulations, procedures, bylaws, and/or law to exercise that authority.

3. Additional Terms and Conditions applicable to Option 1. In addition to the general terms and conditions outlined above, the following terms and conditions apply to Option 1:

A. Embargo Period. Author agrees that once *RMG* accepts a Work for publication, prior to the Work being published by *RMG* and for a period of 12 months immediately following *RMG*'s online-publication of the Work, Author will not publish, reproduce, and/or distribute all or any part of the Work in any and all forms of media, now or hereafter known. After the 12-month embargo period, Author is permitted to publish, reproduce, and/or distribute a copy of all or any part of the accepted Work, along with a link to the Work of record at <https://pubs.geoscienceworld.org/rmg>.

B. Payment. Author agrees to pay the mandatory publication fee of \$850 (or \$650 if they have previously published in the journal). Payment shall be made to *RMG* within 45 days of manuscript acceptance.

4. Additional Terms and Conditions applicable to Option 2. In addition to the general terms and conditions outlined above, but not including the embargo, the following terms and conditions apply to Option 2:

A. Payment. Author agrees to pay the Gold Open Access charge of \$1,500 (or \$1,250 if they have previously published in the journal). Payment shall be made to *RMG* within 45 days of manuscript acceptance.
